b. Levy Charges

Rating levy has gone up to \$2 per player to go to CASPA ASPAQ levy to remain at \$1 – committee can make changes if needed.

- c. Membership Charges
 - Social membership option Julie

Social membership should be eligible for half a vote for CASPA purposes and cost half as much as full membership for ASPAQ and CASPA. Social members are not entitled to reduced tournament fees but can elect to receive Across the Board (electronically only). I believe taking this step will help increase our membership and provide more robust insurance cover. The point has been raised in the past that we will lose money if full members opt for social membership instead, but I believe the increased security in so far as insurance go makes this risk worth taking. I also believe that the quantity of existing social members in New South Wales would make up for any shortfall in Queensland in so far as CASPA revenue goes. In addition to this we should urge CASPA to reduce its membership fees to \$10 per annum, \$5 per annum for social membership. Motion: That we expand our membership categories to include a social membership option and lobby CASPA to do the same.

This motion has been suggested in the past and voted down but it gives all office bearers security from prosecution and enables us to effectively apply for grants for tournament funding. Motion: That ASPAQ take steps to become an incorporated association under Queensland law and adopt a modified version of the current model rules

 - Youth Membership Form Jane

Background and reasons:

At present we have one membership form for all. We have had no or very few youth members in past. We have no form which the parent/guardian has to sign.

When signing up a youth member, I have usually tried to remember to get certain details from the parent and make them aware of what is involved.

I feel this is a bit 'ad hoc' and we need a form to cover everything for our sake and the parents.

I will present a proposed form if this is agreed, but for now, the matters I think should be covered are:

Info about child: Name; DOB (month and year only if preferred).

Phone no; Email. (optional)

Allergies and/or medical conditions we need to be aware of.

Info about parent:

Name. Phone no. Email. (Parent also need to indicate which email (child's or parent's to use for e-atbs, etc)

<u>Consent</u> with signature needed for child's name and photos which may appear online and in print. <u>Signature</u> required from parent stating that:

- 1. Understand information provided only used for Scrabble purposes.
- 2. If child left at a venue without parent, then child is under the supervision of a designated Blue Card holding adult. Must not leave premises etc without permission. Emergency contact for that day must be provided

Motion: I propose that Queensland Scrabble develops a youth membership form.

I am asking now that committee approve this in principle, not every detail of suggested content below. I can present a form for approval later.

• Future QLD Championships – Julie

Motion: That the Queensland championships be held in North Queensland on a triennial basis.

Motion: That future AGM's be able to be joined electronically using a platform such as teams, zoom, or Google meet.

Review of Insurance Policy by Solicitor (lobby to CASPA) - Julie

Motion: That ASPAQ lobby CASPA to engage a solicitor to review our insurance policy and check for loopholes regarding players that are not members. For more information on this please refer to Susan Roberts previous emails on this matter

Payment of a computer operator – Karen

We need to start paying the computer operator: Unless we do this, we will never get new blood trained and ready to help in an emergency or take over completely in the long run. NSW has a rule that over 40 players, their computer operator is paid. Motion: Qld pays the computer operator/tournament director for 30 or more players. (understanding that this means less money for prizes)

Pay rate to be discussed by committee (\$100?). FOR: 16 - Against: 0 - MOTION PASSED

• Roles within the Scrabble community - Karen

We need to start "succession planning" - given that all those currently running tournaments in Brisbane and the surrounding areas are getting old and cannot continue indefinitely. The first step could be to nominate people for specific roles, such as Equipment Officer, as they do in other states. Other roles could include a Public Relations Person (to approach TV and newspapers etc) and a Social Media person. an Advertising Person,. A Website person. A Tournament Organiser. A Catering person. Maybe a fund-raising person and an Online Play organiser. We already have some of these roles, but if we formalise it, we can then make an effort to have backup persons trained and ready in all areas. Motion: Establish roles within the community and prepare members to accept those roles.

• Tournament player recruitment - Karen

We need to make a concerted effort to increase the total number of players supporting tournaments (with a goal to have 30+ at all events). This can be achieved by advertising, and more importantly, by personal contacts to players by organiser/s or other players. Having more players active on Qld Scrabble email list would also help. **Motion: Actively recruit more players to tournaments, starting**

by including 90% or members and potential members on the email list, and 50% on Social media. FOR: 16 – Against: 0 - MOTION PASSED

Matchplay - Karen

Can we please restpre Matchplay, as least for Brisbane area. I suggest 2 sections (under and over 1300, with top 8 in each division going into playoffs. Maybe we can include areas like Toowoomba, by having them perform the first round in Toowoomba. Do Sunshine Coast/Townsville/Gold Coast want the same option? Note that CASPA does not (yet?) allow the playoff portion to be rated (much to my annoyance!). Hence it is virtually a social event, but fun and challenging.

Motion: Reintroduce Matchplay

supervisor if necessary
